AGREEMENT TERM: This Boarding Agreement serves as a legally binding document between Pet Owner and Bark N The Ark Boarding & Groom LLC, The Ark Animal Hospital and pet owners for 1 (one) year. At the end of each term, this agreement will automatically renew for another year, so long as neither party gives written notice of non-renewal to the other party at least 30 days prior to the last day of the term. Bark N The Ark Boarding & Groom, LLC reserves the right to cancel this Agreement at any time for any reason.

VACCINATIONS: For your pet's protection and the protection of all our boarding pets, we REQUIRE all imperative vaccinations and fecal tests are current. Unless proof of exam and vaccination is available upon admission, necessary vaccinations/tests will be performed at the owner's expense.

EXTERNAL/INTERNAL PARASITES: We ask that pets be clean and free of external and internal parasites (fleas, ticks, etc.). If your pet enters with either internal or external parasites, we will provide treatment for your pet at your expense.

BATHING: Should it become necessary to bathe your pet, we will attempt to contact you for permission, however in the event that we are unable to reach you and it is determined that a clean-up bath is necessary, we will bathe your pet and an additional amount will be added to your bill. Please note that a clean-up bath is for sanitation purposes only and not substitute for regular bath.

PERSONAL ITEMS: Please do not bring items with your pet; we cannot accept any personal belongings such as bedding, food bowls, or toys. All of these items are provided for your pet at no additional cost to you. In some cases it may be possible for you to leave a favorite toy for your pet to use during "playtime".

COMMUNICABLE DISEASES: All pets coming into the Bark N The Ark Boarding & Groom, LLC are fully vaccinated; however, it is still possible for a pet to become ill, even if vaccinated. This is not due to any circumstance or condition at Bark N The Ark Boarding & Groom, LLC and you agree that you will not hold The Bark N The Ark Boarding & Groom, LLC and its employees liable in the event your pet becomes ill.

BOARDING HOURS: Drop off and pick up times are available any time, however boarding charges are assessed daily at 7pm.

DAY CARE: Day care is by appointment only and current vaccination records are required.

Boarding Agreement (Continued)

1. Pet Owner certifies to the facility that the owner is over the age of 18 years of age and all information provided about the Pet Owner is accurate.
2. Pet Owner certifies the accuracy of all information provided about the Pet Owner's dog(s) and or cat(s) to the facility.
3. Owner authorizes the facility to obtain and utilize the medical and vaccination records from the Ark Animal Hospital or the pet's veterinarian.
4. Owner agrees not to bring pet to the facility if the pet is exhibiting any signs of illness that may be harmful to the other pets at the facility without the permission of the facility. These include but are not limited to: coughing, diarrhea, vomiting, etc.
5. All Owners understand and recognize potential risk involved with boarding & grooming however, the facility shall further exercise "reasonable care" for owner's pets while in the custody of the facility.
6. Owner gives the facility (in their sole discretion) their consent to act in the owners behalf in obtaining veterinary services from the Ark Animal Hospital should the owner's pet become ill or require medical treatment. All associated expenses incurred shall be the responsibility of the pet owner and the pet owner agrees to indemnify and hold the facility and/or its employees harmless from said expenses.
7. The facility may exercise a change in the type of boarding or daycare to include the removal of pets from group play, if in the opinion of the facility there is a risk of injury or threat to the safety of the owner's or other pets or the facilities employees.
8. Pet owner assumes any and all liability and expenses for injuries inflicted by owners pet upon other pets at the facility, facility staff, and or other persons while in the facility.
9. Pet Owner certifies that all credit card information is accurate.
10. Pet owner agrees to pay for all charges due at the time of service to include special services from veterinary costs as stated #6.
11. Pet Owners agree to abide by the policies and procedures as posted in the facility, available on the website and or in our written boarding agreement.
12. Facility has the right to refuse to release owners pet(s) until all charges have been paid due the facility. The facility is hereby granted a lien on the owner's pet for any and all unpaid charges resulting from boarding, daycare or any other service provided by the facility.
13. Facility has the right to take photographs and/or shoot video of owner's pet while in the care of the facility. This facility may reproduce or post any/all photographs or video content taken as well as pet's name on or in, without limitation, the facility's website, social media pages, social media sites and/or marketing or promotional materials without becoming liable to the Pet owners for any royalty payment. Pet owner hereby releases covenants not to sue and forever discharges the facility of/from any and all claims rights, demands, and other causes of action whatever the nature. Pet owner further agrees that no photography or video may be taken by the owner while in the facility without the written approval of management.
14. Pet owner agrees that the facility's liability in any cause cannot exceed the current chattel value of a pet of the same species utilizing the facility.

This agreement contains the entire agreement between the parties and shall be binding on the administrators, personal representatives, heirs, and assigns of the Pet owner and the facility. Further, owner releases, indemnifies and holds harmless the facility from any all manners of damages, liabilities, losses, claims, costs or expenses caused by action or suits, whatsoever in law or equity including, without limitation attorney fees and related costs arising out of or related to the services provided by the facility. The exception being those which may occur from the sole gross negligence or intentional and willful misconduct of the facility. Any claims relating to this agreement shall be settled by arbitration in accordance with the rules of the Georgia Arbitration Act (GAC). Judgment upon award rendered by an arbitrator may be entered in any court having jurisdiction thereof.

This is an agreement between The Bark Boarding & Groom LLC, The Ark Animal Hospital (referred to as the "facility") and the pet(s) owner/agent/surrogate whose signature appears below (referred to as "Owner.")
